NEW BUSINESS:

Resolution 24-02- Lodging Tax App. MacDougall Invitational-

Police:

COMMITTEE/BOARD/COMISSION REPORTS:

Park Board:

Golden reported from the park board meeting held before council. The city is ready to move forward with the renovation of the pool. This will include construction of an ADA family restroom, update bath house and put a pool liner in. There is \$1 million from Washington State and \$350,000 from an RCO Grant. This will make the project \$755,000 short. The city will look into options on how to make up the difference ie: borrow money from the water department, apply for .09 funds and fundraising. The good news in all of this is the liner has a 20 year guarantee, the pool will be ADA accessible and this will eliminate the huge water loss issue. The bad news is the pool will likely be closed for the season as installing the pool liner will need to be done in good weather. If done in the fall or winter it would add \$1 million to the project as a cover would need to be built to protect from the elements. We have the money from the state and the RCO grant with timelines, the money has to be used or we lose it.

Golden stated the park board is good with the city proceeding.

Also discussed was the need for repairs at the Skate Park.
