# Port of Whitman/City of Colfax Water Agreement:

Retzer informed the council updates and changes have been made by Attorney John Kragt, Public Works Matt Hammer, Councilman Kackman and City Administrator Chris Mathis and are ready for discussion with the council.

Hammer stated once this agreement is updated and approved it will be added to the Master Water Plan. Hammer went on to say city staff services have been removed from the agreement.

## Concerns from council include:

- How much water the port is currently using
- What do they need the water for
- Dual indemnification
- Do they actually need 50 acre feet, modify to 10 acre feet reevaluate at a later date
- If given 50 acre feet the city would likely not be able to reduce amount in agreement for the future
- 3 year process to terminate agreement
- City's water rights should be for citizens of Colfax first

Hammer will reach out for clarification on how many existing wells the Port has, pump data as to how much they currently use, ask them how much they need and what they need the extra water for.

Hammer reported he received a \$140,000 grant from TIB for crack sealing: Thorn, Valleyview, Southview and South Mill Street. The county will do the work for us and the city's share will be \$7,300 for the project. The city will help with prep work.

Retzer received an email regarding grants for the trail from Hauser Addition downtown. Spring of next year is when we will need to look for the grant information.
