City Administrator Chris Mathis reported the city received and accepted a bid from WMS Aquatics for the pool renovations. They plan to begin the project mid-July. WMS has invoiced the city for the down payment for the project and WMS will start the permitting process.

#### **NEW BUSINESS:**

## **Interim Police Chief:**

Retzer introduced the Interim Police Chief Erica Warren. This will be a three month appointment; Officer Tate will also serve as Interim Police Chief after Warren finishes her three months. In that time Retzer encouraged the two candidates to seek training to improve upon themselves before applying again. The city will advertise and open the application process up for the vacant police chief position.

Warren briefly told the council a little about herself. She has been in law enforcement since 2015. She was a Sergeant for Couer d' Alene Tribal Police before taking a short break and deciding she missed it she got back into law enforcement. Warren has been with the City of Colfax since June of 2023.

Warren took the Police Chief Oath of Office.

# **Chicken Ordinance Request:**

Schaefer requested the council revisit the Chicken Ordinance that was previously brought before council. Schaefer has had several citizens request this topic be brought back before the council. Schaefer doesn't want this to be a big issue for the police and doesn't think it would be any more than what they deal with dogs or any other animals in the city limits.

Mathis stated the chicken topic has come before council three times since she has been here. There is an actual ordinance that the Planning Commission approved and we can bring that previous ordinance back before council for review.

Huntwork has concerns with allowing chickens and has had citizens that do not want chickens contact him, he would like it put on the ballot for citizens to vote on.

Discussion ensued whether this should be a council decision or a vote on the ballot.

Mathis stated we could put out another well publicized survey.

Retzer stated the citizens vote the council in here to make good decisions. Retzer went on to say the previous survey regarding chickens results showed the citizens wanted chickens and the council voted it down.

Golden made a motion to bring the Chicken Ordinance back before council, seconded by McRae. Roll Call: All Yes.
